41. TO CONSIDER FUTURE PLANS FOR THE NEW GARDEN OF REMEMBRANCE AT THE WOODHOUSE BURIAL GROUND

The Chief Officer gave a presentation recommending a new Garden of Remembrance, a memorial tree and a 'letters to heaven' post-box.

Councillor Lawton and Salt stated their preference to the half-sized memorials. Councillor Redfern stated that he liked the memorial tree idea.

It was proposed to circulate the presentation to Councillors for further consideration and to review in January when costings and Planning requirements could be considered. All **agreed.**

42. ITEM REQUESTED BY COUNCILLOR HARPER- TO IDENTIFY A NEW BURIAL SITE AS SOON AS POSSIBLE

Councillor Harper was not in attendance, but all Councillors understood the importance of looking for land that could be purchased for this purpose.

Councillor Yates suggested that memorial trees could be planted as an alternative.

43. TO CONSIDER THE BUDGET FOR THIS COMMITTEE FOR 2024-25 (2023-24 INFORMATION TO-DATE ATTACHED)

The Chief Officer detailed the current funding allocations for this Committee.

Councillor Jackson proposed that £10,000 could be allocated for allotments and a further £20,000 for the garden of remembrance development, seconded by Councillor Jones. All **Agreed**.

It was noted that additional spend might be required for the Butterfly Garden. Members of the Committee were invited to attend the guided tour that week at 11am.

44. JOBS FOR LENGTHSMAN (STANDING AGENDA ITEM)

Councillor Yates reported that the hedge on the curve at the top of the bypass requires cutting and at Meadows Way there is a large bush encroaching on the pathway.

Councillor Garvey requested that the pathway on the corner of Leek Lane to Stoneyfields be considered.

45. TO CONSIDER FUTURE RENT PAYABLE BY THE CAFÉ AT THE VISITOR CENTRE

Councillor Jones declared an interest as he knows the tenant.

Councillor Jones stated that water meterage needed to be considered, and suggested to take views from local surveyors based on the facilities. It was agreed that this was an appropriate way forward.

46. TO CONSIDER ADDING A SPOUSE TO EXISTING ALLOTMENT TENANCY AGREEMENTS

There was discussion about the issues of inheriting allotment, and it was proposed that legal advice should be sought. All agreed to review this again with further information.
